1. COMPANY PROFILE

Dedicated Freight Corridor Corporation of India Limited has been incorporated under the Indian Companies Act, 1956 to plan and construct Dedicated Rail Freight Corridors (DFCs) in the country. To start with, DFCs on the Western and Eastern trunk are stated to be constructed. The Company would need to devise various innovative strategies and modalities for completion of the projects. It is a Schedule-'A' CPSE under the administrative control of Ministry of Railways.

Its Registered and Corporate offices are located at New Delhi.

The authorized and paid up capital of the Company was Rs. 4000 crore and Rs. 774.29 crore respectively as on March 31, 2012.

2. JOB DESCRIPTION AND RESPONSIBILITIES:

Director (Infrastructure) is a member of the Board of Directors and reports to the Managing Director. He has the overall responsibility for activities such as design, contract packaging, bidding framework/documentation, bidding process and award as also the responsibility for all construction and maintenance activities. He is required to provide leadership guidance and support for the execution of projects.

3. ELIGIBILITY

I. AGE: On the date of occurrence of vacancy:

- (i) Minimum 45 years.
- (ii) Not more than 58 years for internal candidates and not more than 57 years for others.

The age of superannuation is 60 years.

II. QUALIFICATION AND EXPERIENCE:

The Candidate should be an engineering graduate or equivalent preferably in Civil Engineering with good academic record from a recognized university/institution. He should have adequate experience at a senior level in a large organization of repute. Persons with experience in the field of mega construction projects and general management of railway construction projects would have added advantage

Provided that minimum qualification is relaxable in the case of internal candidates and Government officers with relevant and adequate background and experience.

III. PAY SCALE:

(a) Central Public Sector Executives.

Executives holding posts in the pay scale of:

- Rs. 7250-8250 (IDA)
- Rs. 9500--11500 (IDA) Post 01.01.1992
- Rs. 20500--26500 (IDA) Post 01.01.1997
- Rs. 51300--73000 (IDA) Post 01.01.2007

- Rs. 18400-22400 (CDA)
- Rs. 37400--67000 + GP Rs. 10000 (CDA)

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

(b) Government Officers

Government officers of the level of Joint Secretary in Govt. of India or on equivalent scale of pay or Major General in the Army or equivalent rank in Navy/Air Force, on the date of application will be eligible for consideration on immediate absorption basis.

4. DURATION OF APPOINTMENT

The appointment shall be for a period of five years or upto the date of superannuation whichever is earlier.

5. SUBMISSION OF APPLICATIONS

Prospective candidates from the Central Public Sector and Government officers shall send their applications, through proper channel, in the format at Annexure I.

The applications for various categories of the officers are routed THROUGH PROPER CHANNEL AS FOLLOWS:

- a) for Government Servants: through Cadre Controlling authority.
- b) for CMD/MD/Director in Central PSE: the concerned administrative Ministry.
- c) for below Board level in Central PSE: the concerned CPSE.

6. CERTIFICATION BY CANDIDATE

- a) Candidate has to submit his/her willingness for the post at the time of interview itself clearly stating that he/she will join the post, if selected. If any candidate, does not initially give his/her willingness, he/she will not be interviewed.
- b) If any of the candidates who appeared for the interview and is selected by the PESB, gives his/her unwillingness after the interview is held, but before the appointment is processed, would be debarred for a period of two years for being considered for a Board level post in any PSE other than the one to which the candidate belongs.
- c) If any candidate gives his/her unwillingness after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment from being considered for a Board level post in any PSE other than the one to which the candidate belongs.
- d) In the above cases, no request for relaxation or otherwise would be entertained.
