This invitation for prequalification follows the general procurement notice for this project that appeared in United Nations *Development Business* of 10.01.2013 on-line.

The *Government of India, Dedicated Freight Corridor Corporation of India Ltd (DFCCIL)* has applied for a loan from the *International Bank for Reconstruction and Development (IBRD)* towards the cost of EDFC 2 Project- and intends to apply part of the proceeds of this loan to payments under the contract for Contract Package 204 - *Design, construction, supply, installation, testing and commissioning of 2 x 25 KV electrification, and associated works of double track railways lines under construction on design build lump sum basis for Mughalsarai – New Bhaupur section of Eastern Dedicated Freight Corridor.* The *Dedicated Freight Corridor Corporation of India Ltd.* intends to prequalify contractors and/or firms for *Contract Package 204 as per details given below.* It is expected that invitations for bid will be made in August, 2014.

Prequalification will be conducted through prequalification procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits*, January 2011, and is open to all bidders from eligible source countries, as defined in the guidelines.

Interested eligible Applicants may obtain further information and inspect the prequalification document at the *office of Dedicated Freight Corridor Corporation of India Ltd.* at the address below during *office hours, i.e. 0930 to 1800 hrs.* A complete set of the prequalification document in *English* may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a non-refundable fee of *INR. 10,000/- or 200 US dollars.* The method of payment will be through Demand Draft or Banker's Cheque drawn in favor of *Dedicated Freight Corridor Corporation of India Ltd. payable at New Delhi.* The Pre-Qualification document can be obtained from the office of DFCCIL in person on any working day. If the applicant desires, the document be sent by post/courier service, then an additional charge of *INR. 1,000/- for inland delivery and INR. 5,000/- or USD 100 for overseas delivery* shall also be paid along with the fees stated above. DFCCIL shall not be responsible for any postal delay. The Pre-Qualification Document can also be downloaded from DFCCIL website www.dfccil.org. If the document is downloaded from website, the applicant must deposit the non-refundable fee of *INR 10,000/- or USD 200* in favour of *Dedicated Freight Corridor Corporation of India Limited, payable at New Delhi along with application.* In case of any discrepancy between the documents downloaded by the prospective bidder and the Bid Documents (hard copy) of DFCCIL, the latter shall prevail.
