The Government of India, Ministry of Railways has applied for a loan from the Japan International Cooperation Agency (JICA) toward the cost of the Western Dedicated Freight Corridor Project and intends to apply part of the proceeds of this loan towards payments under the Loan Agreement No. ID-P209 & ID-P229. The Dedicated Freight Corridor Corporation of India Limited (DFCCIL) intends to appoint contractors and/or firms for Design and Construction of Train Protection and Warning System (TPWS) works for double line track with 2 x 25kVAC, 50Hz, overhead catenary system capable of operating at a maximum train speed of 100km/h.

**Brief Description of Works:** Design and Construction of Train Protection & Warning System (TPWS) for Rewari – JNPT Section including Testing and Commissioning on Design-Build Lump Sum Price Basis of Western Dedicated Freight Corridor on Post Qualification Basis.

The selection of the Contractor will be made as per procedure specified in the Guidelines for Procurement under Japanese ODA Loans, March 2009.

A complete set of the bid document in English may be purchased by interested applicants on the submission of a written application to the address below and upon payment of a nonrefundable fee of Rs. 50,000/- or US \$1000. The method of payment will be through Demand Draft or Banker's Cheque drawn in favour of Dedicated Freight Corridor Corporation of India Limited, payable at New Delhi. Bid Document will be available at the address below with CD-ROM including Forms in Microsoft Word version at the cost of Rs. 50,000 (Rs. Fifty Thousand Only). The Bid document with CD-ROM can be obtained from the office of DFCCIL in person during 11:00 hrs. to 17:00 hrs on any working day. If the applicant desires that the document be sent by post/ courier service, then an additional charge of Rs. 10000/- for inland delivery and Rs. 25000/- or US \$ 500 for overseas delivery shall also be paid along with the fee stated above. The request for sending Bid Document by post/courier service must be received in the office of DFCCIL with requisite fee before 01-10-2014.
