Government of India has applied for financing from the World Bank toward the cost of the Eastern dedicated Freight Corridor Project-3, and intends to apply part of the proceeds for **Quality and Safety Auditing Consulting services** for construction of Single line Electrified (2X25 KV) Railway Track complete with Signaling & Telecommunication system and related infrastructure for Sahnewal - Khurja section (Approx. 397 Route Kms) and double line Electrified (2X25 KV) Railway Track complete with Signaling & Telecommunication system and related infrastructure for Khurja - Dadri link (Approx. 46 Route Kms) of Eastern Dedicated Freight corridor.

The Quality and Safety Auditing Consulting services (“the Services”) include third party independent monitoring, to reasonably ensure that quality and safety standards and guidelines as stated in various contract agreements are being followed and resources are available as required to achieve implementation schedule. The scope of services would include examination of the quality of works; conformance with quality norms, and conformance with performance criteria as described in the Specifications of Contracts, conformance of all safety requirements and resource availability as per the implementation schedule. The QSAC will review the quality control documentation for goods purchased and works constructed on a sampling basis sufficient to achieve a reasonable confidence in the adequacy and quality of such documentation and controls.

The Dedicated Freight Corridor Corporation of India Ltd. now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing shall be done based on company profile, Turnover of the company in last five financial years, experience of the company in similar assignments covering components of assignment during last seven years, available permanent staff for similar assignment and any other relevant information provided by the applicant to prove their ability to perform the services in this assignment. Information to be provided by the applicant are included as Annexure.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers dated January 2011, revised July 2014 (“Consultant Guidelines”), setting forth the World Bank’s policy on conflict of interest.

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the QCBS method set out in the World Bank’s Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers dated January 2011, revised July 2014 (“Consultant Guidelines”).

<sup>2</sup> For the purpose of brevity of information, the consultancy work pertaining to Railway lines of more than 50 Track Km should only be included.

<sup>3</sup> Only those assignments should be included, which have been carried out by the applicant. The assignments carried out by parents/sister companies should not be included.
